



17th APT Policy and Regulation Forum for Pacific (PRFP-17)

Nukualofa, Tonga (Hybrid), 3 - 5 September 2024

CONCEPT NOTE

1. Background/Context

The Pacific region is made up of isolated and dispersed islands, requiring powerful ICT solutions to bridge distances and connect communities. International organisations, governments and private sector partners are increasingly investing in ICT infrastructure and capacity building initiatives to enable Pacific countries to participate fully in the global digital economy. These initiatives aim to build more inclusive and resilient digital ecosystems, empower Pacific communities, promote sustainable development and reduce the impact of climate change and natural disasters. Given these circumstances, it would be beneficial for the Pacific countries to have a shared platform to exchange information on telecommunications and ICT development policies and regulations, and to collaboratively discuss future strategies for individual nations and the Pacific community.

The APT Policy and Regulation Forum for Pacific (PRFP) functions as a subregional platform for this purpose and has become a leading event for addressing the shared challenges in telecommunications and ICT development encountered by Pacific members. Following APT's strategic plan, PRFP meetings strive to provide practical support and insights into policy and regulatory issues by focusing on the specific concerns of Pacific members.

As part of respecting and providing practical support for the "Lagatoi Declaration" adopted at the 4th Pacific ICT Ministerial Meeting (August 28-29, 2023), this year's PRFP meeting will also structure its sessions based on the priority areas agreed upon in the declaration. The meeting aims to support Pacific members in understanding policy and regulatory trends, thereby enhancing their capacity to address emerging opportunities and challenges. Ultimately, the meeting will provide an opportunity to discuss ways to achieve economic development and prosperity within the Pacific region.

In the special roundtable session of PRFP-17, following the discussion and expected content of the Ministerial Declaration, Ministers/Head of Regulators from APT Members will update policy and regulation issues in their countries and share insights, experiences, lessons learned, policies being implemented about telecommunication and ICTs.

Also, the meeting features various thematic sessions on 'Empowering Pacific: Navigation Digital Transformation and New Digital Order', 'Unleashing Digital Innovation: The Entrepreneurial Frontier', 'Digital Infrastructure: Exploring Infrastructure Evolution', 'Enhancing the Trustworthy Digital Environment', 'Digital Literacy for All: Promoting Inclusive Access to Digital Era' and 'Resilience in Crisis: Advancements in ICT for Disaster Management'.

PRFP-17 also offers closed sessions for policymakers and regulators, where they can freely exchange and discuss their views and information on critical ICT issues in the Pacific.

2. Objectives

The specific objectives for PRFP-17 are to:

- Discuss current policy and regulation trends in Pacific countries in the digital era.
- Examine and share information on digital transformation initiatives undertaken or that can be undertaken by the Pacific countries.
- Discuss policy and regulatory measures to foster the development of innovative services through the digital innovation and entrepreneurship.
- Provide updates on the latest digital Infrastructure developments and challenges in the Pacific region, including policy and regulatory aspects.
- Discuss strategies for building cybersecurity capacity and potential cooperation on cybersecurity issues.
- Explore measures to achieve digital inclusion through digital capacity building and skills development for all citizens, including vulnerable group.
- Provide updates on disaster management technologies and projects, sharing best practices in disaster preparedness, mitigation, and recovery.
- Hold a closed session for policymakers and regulators in Pacific countries to discuss other common ICT issues of concern.

3. Expected outcomes

The meeting will be conducted as a hybrid meeting. The provisional agenda and tentative programme of the PRFP-17 are enclosed herewith and annexed to the concept note (See Annex A and B for more information).

Specific outcomes include but not limited to:

- Identified major policy and regulatory concerns for Pacific countries.
- Increased awareness of policymakers and regulators regarding the latest issues in telecommunication and ICT.
- Improved understanding and Identified challenges faced by policymakers and regulators on various thematic topics, including digital transformation, digital innovation and entrepreneurship, digital infrastructure and digital islands, security and trust, digital capacity building and skills development, and disaster management.
- Explored potential solutions and cooperation on various thematic topics, including digital transformation, digital innovation and entrepreneurship, digital infrastructure and digital islands, security and trust, digital capacity building and skills development, and disaster management.

4. Timing

The hybrid meeting of the PRFP-17 will be a 3-day event from 3 to 5 September 2024. The meeting will be organised in person in Nukualofa, Tonga and via Zoom meeting platform from 9:00 AM – 17:00 PM (UTC+13).
