**Subject: The 49th Session of the Management Committee of
the Asia-Pacific Telecommunity
9 – 12 December 2025, Bangkok, Thailand (Hybrid Meeting)**

I am pleased to inform you that the 49th Session of the Management Committee of the Asia-Pacific Telecommunity (MC-49) is scheduled to be held from 9 to 12 December 2025 in Bangkok, Thailand with physical attendance as well as virtual/online participation through APT Zoom meeting (i.e., hybrid meeting). MC-49 will be hosted by Ministry of Digital Economy and Society, Thailand and organized by the APT.

MC-49 will review the activities in 2025 and consider and approve the Work Programme and Annual Budget for 2026. In addition, MC-49 will discuss how to prepare for the 17th Session of the General Assembly of the APT (GA-17), including preparation for the Strategic Plan of the APT for 2027-2029. Prior to MC-49, the Seminar on Progress in the APT for the year 2025 (SPA-2025) will be held on 8 December 2025 at the same venue.

I would like to emphasize that the attendance to MC-49 of your Administration is essential to enable approval of the Work Programmes and Annual Budget for 2026 and other issues as well as to ensure the required quorum for MC-49 in accordance with Article 9, Paragraph 8 of the Constitution of the APT. In case you plan to submit your contributions to this MC-49, please follow Rule 14 of the Rules of Procedure of the MC.
