I would like to inform you that the Asia-Pacific Telecommunity (APT) will organize the 3rd Meeting of the APT Preparatory Group for the ITU Plenipotentiary Conference 2026 (APT PP26-3) from 30 March to 2 April 2026 in Bangkok, Thailand via physical meeting with remote participation modality. The Meeting will be hosted by the Office of the National Broadcasting and Telecommunications Commission (NBTC) of the Kingdom of Thailand.
