Subject: The 27th Meeting of the South Asian Telecommunication Regulators' Council (SATRC-27), 20 – 22 October 2026, Colombo, Sri Lanka

I am pleased to inform you that the Asia-Pacific Telecommunity (APT) will organize the 27th Meeting of the South Asian Telecommunication Regulators' Council (SATRC-27) in Colombo, Sri Lanka from 20 to 22 October 2026. The meeting will be hosted by the Telecommunications Regulatory Commission of Sri Lanka (TRCSL). SATRC-27 will be held as a physical meeting with remote participation modality. Remote participation will be arranged through Zoom meeting platform.

The SATRC meeting is convened annually to discuss and coordinate regulatory and other related issues in the fields of telecommunications and ICT that are of common concern to the regulators of SATRC Member countries. The meeting brings together the heads of telecommunications regulatory authorities and designated senior-level officials from SATRC Member countries.

SATRC-27 will discuss the key policy and regulatory issues in the SATRC countries and review the implementation of SATRC Action Plan Phase X adopted at SATRC-26. SATRC-27 will include sessions for Regulators' Roundtable, Industry-Regulator Dialogue, Industry Session and Sharing Regulatory Experiences Sessions to facilitate the development of the telecom/ICT sector in South-Asia. The Regulators' Roundtable will be held exclusive for the head of regulators to discuss and share thoughts on important regulatory issues that need regional collaboration specifically for the SATRC Member countries and generally to the Asia-Pacific region.

I am pleased to invite your head of the regulatory bodies and high-level officers dealing with SATRC activities to participate in SATRC-27. We also encourage the participation of the relevant stakeholders in your country who can contribute to the work of SATRC.
