Subject: The Intersessional Meeting of the Ad Hoc Group on Working Methods of the APT Conference Preparatory Group for WRC-23 (APG23-IMAHWM) 2 - 3 March 2022, Virtual/Online Meeting

I would like to inform you that the 3rd Meeting of the APT Conference Preparatory Group for WRC-23 (APG23-3) held virtually from 8 to 13 November 2021 has decided to organize an intersessional meeting of the Ad Hoc Group on Working Methods of APG virtually. With this regard, based on the consultation with the Chairman of Ad Hoc Group on Working Methods as well as the Chairman of APG-23, it has been decided that APT would organize the Intersessional Meeting of the Ad Hoc Group on Working Method (APG23-IMAHWM) from 2 to 3 March 2022 as a virtual/online meeting.

The objective of this intersessional meeting would be to further consider possible revisions to the APG Working Methods and to discuss in detail the issues identified above that were raised at APG23-3. The output of the meeting would be a consolidated revised working document towards the possible revision of the APG Working Methods for consideration by APG23-4. APG23-4 may then decide to submit a proposed revision to the APG Working Methods to the Management Committee of the APT for consideration at its next meeting.

Please ensure that relevant experts from your administration/organization who are well familiar with the activities of APG-23 are included in your delegation.
