Subject: Nomination of candidates for the position of Chair and Vice-Chairs of The APT Telecommunication/ICT Development Forum

Please refer to the APT letters (Ref. APT/2024/ADF-21/INV-01-F and APT/2024/ADF-21/INV-01-NF, dated: 30 May 2024) inviting your administration/organization to attend the 21st APT Telecommunication/ICT Development Forum (ADF-21) from 6 to 8 August 2024 in Jakarta, Indonesia with hybrid format (both physical and virtual/online attendance through Zoom meeting).

In this regard, I would like to invite your administration/organization to consider nominating suitable candidate(s) for the positions of Chair and/or Vice-Chairs of ADF. I would like to emphasize that the roles of Chair and Vice-Chairs of ADF are very important for the activities of ADF.

Nomination of candidate(s) should be submitted as an official letter signed by the high-level official or APT focal point of your administration/organization along with a CV of the candidate describing their expertise in ICT Development as well as experience in APT activities. Please send your nomination letter to the APT Secretariat as an attachment to an email addressed to apt.int by 20 July 2024.

I thank you for your consideration and look forward to receiving a nomination from your administration/organization for these positions.
